Introduction

- Sexual orientation and gender identity (SOGI) data has been successfully collected in a survey context for well over a decade
- ► While these measures are not perfect and ongoing research seeks to improve them, the existing recommended questions have been shown to be reliable measures and have been incorporated into many federal surveys
- ► There have been increasing efforts to expand that collection beyond surveys
 - Executive order 14035, Diversity, Equity, Inclusion, and Accessibility in the Federal Workforce
 - Executive order 14075, Advancing Equality for Lesbian, Gay, Bisexual, Transgender, Queer, and Intersex Individuals
- While collecting SOGI data in a workforce setting along with other demographic data is important, it comes with challenges that are different from surveys and may need different questions

PFS Survey

Pride in federal service (PFS)

- PFS is a cross-government employee organization
- PFS includes over 900 federal employee members, across all cabinet level departments distributed broadly across the states, territories, and overseas postings
- Most PFS members have an LGBTQIA+ identity, some have LGBTQIA+ family members or are allies

Methods

- Convenience, opt-in sample gathered from anonymous respondents to a PFS list-serve invitation to participate
- Survey was not split panel, we included two versions of sexual orientation questions, and two versions of gender identity questions respondents were asked to answer and comment on preferences for questions
- We asked follow up questions about willingness to provide this information in a federal workforce data, willingness to allow others to answer questions, and impact of state level legislation on willingness to disclose information
- Collected some basic demographic categories.
 Did not collect any identifiable information

Sample Information

Sample

- 472 completed survey 1
- ▶ 101 identified as gender minority (21%)
- 256 completed survey 2
- > 79 identified as gender minority (31%)

Limitations

- Both questions were presented one after the other
 - Context effects cannot be ruled out
 - Confusion of having 2 questions may have been an issue for some respondents
- Convenience sample of employees interested in LGBTQI+ issues in the federal space
 - May not be representative of all federal LGBTQI+ employees



Questions

- What were the differences in how gender minority respondents report between questions in the PFS survey?
- How did the addition of a nonbinary option impact the way people categorize themselves?
- Do respondents express a preference for one question?
- What was the main feedback respondents gave on the questions?
- How can these findings help inform decisions about collecting workforce data?



Write in information

- Some respondents selected no preference because they could not remember both options
- Issues with Q1 tended to reflect existing methodological concerns and focus on use of sex at birth, lack of mark all that apply, mixing sex and gender terms, and inclusion of transgender as a gender category
- Issues with Q2 were less frequent and tended to focus on use of sex terminology and confusion with the term transgender experience




▶ Despite more opportunities to give open-ended feedback there were only about 15 comment s about the question in survey 2 compared to over 200 in survey 1

- Respondents who preferred "Do you consider yourself to be transgender or have a trans history? Thought it was more inclusive

- ■While we tested this question in the context of workforce data collection, it may work well in other contexts
- ■The modified two-step question that includes a question about being transgender overcomes many of the shortcomings of the two-step question that uses sex at birth while retaining the ability of respondents to identify as both male and transgender or female and transgender.
- ■The addition of nonbinary and the ability to select both nonbinary and transgender allows the disaggregation of transgender, transgender and nonbinary, and nonbinary respondents. Some limited research is starting to find that there may be significant differences between these groups.
- ■The ability to disaggregate transgender, nonbinary and other gender minority terms is consistent with guidance from the Federal Evidence Agenda to be able to disaggregate wherever possible- even if public use data must be combined for release, disaggregation allows for analysis of differences in these groups and changes in reporting overtime
- ■The addition of nonbinary and the ability to select nonbinary and transgender also reduces write in responses which could be important for workforce demographics where write-ins are not the norm and for surveys with limited ability to code write ins

Write in difficulties

Some respondents selected no preference because they could not remember both options

- "I'm already confused, didn't know I needed to remember what options were for each answer."
- "Regarding the questions above, I do not remember what the options were and it appears I can't go back, so I picked no preference."
- "I don't recall the difference between the options (seemed really similar to me)and am not able to return to the previous page."



Write-ins Q1:

Issues with Q1 tended to focus on use of sex at birth, lack of mark all that apply, mixing sex and gender terms, and inclusion of transgender as a gender category

- "I was wondering the purpose of the sex assigned at birth question. If it's not the same as the legal markers nor the gender identity, it seems like an unnecessary, invasive and dysphoria inducing question."
- "The sex at birth question was inadequate and leaves out the Intersex population entirely."
- "My first choice for gender questions is a "check all that apply" that lets me check both male and trans, but since that's not an option, it feels slightly less invasive to ask if I'm trans than to ask assigned sex/what's on my birth certificate. The birth certificate formulation also might be complicated for intersex folks and might end up not capturing folks with intersex conditions who do identify as trans."
- ▶ "Gender should be woman or man, not female or male; let's not conflate/confuse gender with sex
- ► "Question 1: I would normally click male, as transgender is not my gender, it just describes my gender experience."
- Many transgender persons also consider themselves to be the gender they have transitioned into. Thus, a choice of male, female, transgender is not sufficient."
- "Transgender, as a gender doesn't make sense to me. It's like an adjective on top of gender, not a gender itself."
- "In the option 1 gender identity questions, it was unclear because "transgender" is an adjective used to describe someone's gender experience, not a gender in and of itself, so it can't be categorized with the other answer choices."



Write-ins Q2:

Issues with Q2 tended to focus on use of sex terminology and confusion with the term transgender experience

- "'Male' and 'female' are terms typically associated with sex, not gender. Therefore, for any of the gender identity questions, I would not recommend including "male" and "female" as responses (I'd recommend replacing these with 'man' and 'woman')"
- " 'Transgender or transgender experience' needs a bit of explanation. What is 'transgender experience'?"
- "As a transgender person, questions surrounding the 'transgender experience' don't resonate with me. I typically don't care for such wording. A possible alternative may be: 'Are you transgender?' or 'Do you identify as transgender?' Just my 2 cents!"

For both question sets and for SO questions, some respondents asked for additional categories

- "My sexual orientation is not as well known, so I was not surprised that mine was not listed. I think the gender identity though should incorporate more identities."
- ► "Enough people use 'queer' as an identity that it should be a listed option, especially for sexuality but also for gender."



Write-ins survey 2 issues

Suggestions similar to survey 1 included adding additional categories, mark all that apply

- "Definitely wish there were more inclusive options than the few listed"
- "I think for statistical purposes, adding in transgender male/female for gender would be nice, especially if non-binary is an option. Or simply adding "cis" before male or female, and having an additional male/female option."
- ► "As long as you allow other, and maybe allow multiple choice, I think it's okay enough!"

New feedback for survey 2 regarding preference for sex questions

- "...I am gender-apathetic or anti-gender, yet feel a strong tie to my sex"
- "I recommend differentiating between sex and gender identity and having a question for both."




Preferences for transgender question wording with quotes

Respondents who preferred "Are you transgender?" thought it was straightforward and clear or did not like the do your consider yourself wording or the other question.

"It is concise and easy to understand. It leaves room for the respondent to answer however they interpret the question, whether that's currently trans/transgender, having trans history, etc."

"The more straight-forward the better. "Do you consider yourself..." feel conditional in a way that undermines the legitimacy of the question/answer."

Respondents who preferred "Do you consider yourself to be transgender or have a trans history? Thought it was more inclusive

"Sounds closer to how I understand my transness versus how others may perceive me

Both of these options work well, more testing may be needed
